It would be advantageous in this matter if Northrop & Johnson, the broker for the sale of the Alfa Nero, would issue a public statement setting out its involvement in the sale, as well as the sum paid and to whom payment was made. The claims and allegations are designed to bring your company into disrepute.

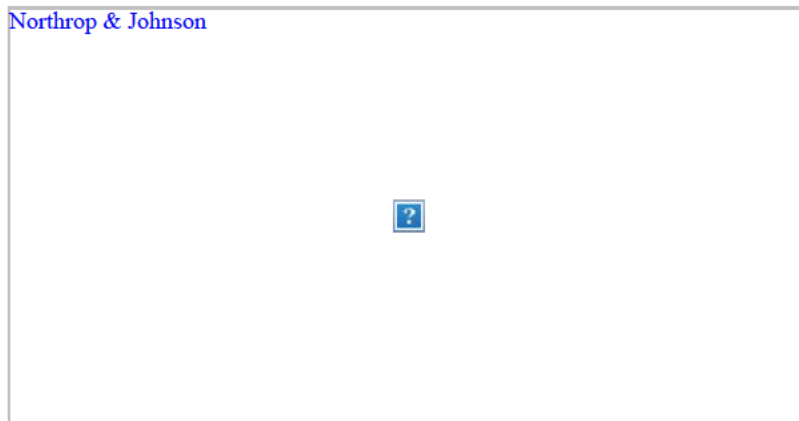
